

PRIVACY POLICY

Tennessee Underwriters, Inc. (herein referred to using “we,” “us” or “our”) is the owner of information collected on this website. The information that we receive depends on your actions when visiting our website.

Information Collected

Working with you and others, we gather the necessary information from you and other public and insurance sources to help assist in the insurance search and placement coverage as you may request, or as you may otherwise direct or authorize (such as through another insurance agent or broker).

We collect nonpublic personal information about you from the following sources:

- A. Information we receive from you on applications and/or other forms or which you supply, such as in emails or other correspondence or by using a “contact us” form or submission on our website. This information may include your name, address, social security number, taxpayer identification number, assets, income and beneficiary designation.
- B. Information sent to us at your direction and/or authorization by insurance agents, brokers or companies or others, such as applications for insurance, which may include the information listed just above.
- C. Information about your transactions with us or others, such as your policy coverage, premiums, contracts, productivity and payment history.
- D. Information we receive from a consumer reporting agency, such as your creditworthiness and credit history.

Also, when you visit our website or download information from our website or web pages, please be aware that we automatically collect and store the following information about you:

- The date and time you accessed our website, sent us an email or sent us a request.
- Your internet protocol (IP) address, or the proxy address of your internet service provider.
- The resource or pages on our server accessed by you, such as the web page, image, etc.
- The name and version of your web browser.
- The content of any received cookie.
- The uniform resource locator (URL) that was accessed before you accessed our website. The URL may be an outside address that is not related to our website or server.

- Other status codes and values resulting from the web server responding to your email, request or accessing our website, HTTP status code, Windows NT code, number of bytes sent, number of bytes received, duration (in seconds) of access or in fulfilling the request, server port number addressed, and protocol version.

Information Disclosed

In order to assist in procuring, servicing, billing for, processing and maintaining insurance, reinsurance, or stop loss or excess loss insurance for you, we may exchange such nonpublic personal information listed in A – D above with other insurance-related parties, such as insurance companies and other insurance agents and brokers that are similarly obligated as us under federal and/or state privacy laws. However, except as stated just above, we do not otherwise disclose any nonpublic personal information about our customers or former customers to anyone except as permitted by law.

Opt Out Right

If you prefer that we not disclose nonpublic personal information about you to unaffiliated third parties, you may opt out of disclosures to such unaffiliated third parties (other than those permitted by law).
